In consideration of our child being permitted to enroll as a camper at Starlight Farms Pony Camp we fully and completely release and discharge Starlight Farms and Highland Farms and its owners and employees, from any and all claims that either we or our child might have for damages or injuries arising from use of or working with horses, other farm animals, or from any other camp activities, and we agree to indemnify Starlight Farms and Kelly Perfetto and Highland Farms and James and Denise McMullan from any such claims made by or on behalf of our child.

# Important Information and Camp Policies

**To Enroll:** Send a completed and signed Enrollment Form along with a \$50.00 deposit (*non-refundable*) to Kelly Perfetto at Starlight Farms.

**Payment:** Balance of tuition is *due on first day of camp*. Those who wish to do so may prepay the tuition in installments - in whatever amounts and at whatever time they choose. Although the deposit is not refundable, these prepayments are refundable until 2 weeks before arrival at camp. \*If balance is not received when due the camp director has the right to give that space to a child on the waiting list.

**Refunds:** Except for the deposit, all tuition paid in advance is fully refundable until the due date (2 weeks before arrival at camp). After the due date the tuition is not refundable for any reason, including withdrawal or dismissal. \*The single exception - if a camper must leave camp for medical reasons, the unused portion of the tuition will be refunded.

**Please Note:** The camp director reserves the right to dismiss without refund any camper whose presence, in their judgment, is detrimental to the camp, to the other campers, or to the camper herself.

**Clothing:** It is important campers wear play type clothing that is appropriate to riding. We spend time getting dirty, painting and washing ponies. Children should wear appropriate clothing and, if necessary, bring a change of clothes for the crafts/painting part of camp. Starlight Farms is not responsible for damages to personal belongings/clothing during camp activities.

**Session Change:** Choice of sessions may be changed at any time if space and circumstances permit.

**Visiting:** There is *no visitation* during camp without prior approval as it can be disruptive to the schedule. We also strongly feel that one of the benefits of going to camp is to gain in self reliance and confidence. Special circumstances are always taken into consideration.
